Extension of contract scope and value to allow delivery of urgent international aid (pumps and flood barriers) to support Ukraine's response to ongoing severe flooding and related services.

As part of that, the Environment Agency has agreed to send aid in the form of pumps, flood barriers, and other flood response-related equipment.
