1. Introduction

The Centre for Digital Public Services (CDPS) is conducting preliminary market engagement to inform the establishment of a dynamic market for digital training providers, in accordance with the Procurement Act 2023. The dynamic market will facilitate the procurement of high-quality training services to meet the cyber, digital, data, and technology training needs across public sector organisations in Wales.
