ECC is the Waste Disposal Authority for Essex and is responsible for the management of circa 700,000 tonnes of varying types of household waste per annum. The Authority operates a network of 21 Recycling Centres for Household Waste and works with our 12 district and borough councils that make up the Waste Collection Authorities across Essex. This has been procured to ensure material collected can be disposed of through the most economically advantageous outlets.

The successful contractor will broker materials on ECC's behalf ensuring optimum value is obtained. The contractor will ensure destinations for the recycling, reprocessing and disposal remain compliant with relevant legislation.

The contractor may be required to broker waste collected at additional collection points as required.

The contract is for a duration of 3 years with an option to extend the term for up to a further 3 years if agreed by the Authority and otherwise provided for in the contract.
