Sellafield Ltd is now seeking to enter into a contractual arrangement with Stork Technical Services UK Limited arrangement for the Provision of Inspection and Quality Assurance Services including but not exclusive to welding; mechanical; industrial coating; CE&I inspection and Non-Destructive Testing (NDT) supported by welding and metallurgy
