The Supplier will clean the first 50 stations within a 3-month period and demonstrate further working capability to potentially continue for a further 6 months and another 100 stations. Upon successful delivery of deep cleaning of the first of 50 stations included this tender exercise, there may be an opportunity to deliver the further stages amounting to 100 stations over 6 months via a contract extension.
