- Adapt service provision to meet the needs of our diverse communities and reduce inequalities tailoring the level support for those with more complex health needs and those that need it most.
- Work across services and organisational boundaries improve public health outcomes.
- Support delivery of the council’s Tobacco Control Strategy, including a focus on prevention with children and young people.
