The Enhanced Health Visiting Service aims to reduce vulnerabilities and address the inequalities exacerbated by the pandemic, by providing greater autonomy for the Service to target resources where they are most needed. The successful Provider is required to develop and maintain close working relationships with wider partners such as children's social care, primary care, early years services and early education providers to enable full integration of services. This in turn will provide a more joined-up, cost-effective service which can be tailored to individual needs, paving the way to deliver a service across a wider range of public health issues.
