## **VII.2) Information about modifications**

### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

The contract was advertised and awarded for a period of 5 years with 2 x 12 months extension options. The extension period had not been factored into the total contract value which was published in the award notice. This is a modification to the contract value, the modified value now includes the additional two years extension.

### **VII.2.2) Reasons for modification**

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

An error was made on the initial contract award notice. The contract was awarded for 5 years with 2 x 12 months extension options, the additional cost of the extension had not been included in the total value of the contract.
