NHS Frimley ICB ("the Commissioner") sought to commission provision to provide adult hospice inpatient, outpatient and community services for all patients requiring hospice intervention for palliative and end of life care who are registered with a GP practice in the East Berkshire area.

The provider will work in close partnership with the ICB and stakeholders in delivery of the model of provision. The model will aim to achieve best value and excellent patient outcomes by developing planned pathways and processes towards the shift of activity from hospital

settings to hospice, care homes and home settings. There will be an emphasis on achieving the preferred place of care for patients and their carers/families in an efficient and timely manner.
