The victim may have been criminally exploited even if the activity appears consensual. The trauma some C&YP experience heightens vulnerability, decreasing health and social outcomes and increases their risk of exploitation and entering the Criminal Justice System (CJS). Building resilience, in those affected, decreases the risk of victimisation and results in a reduction in offending behaviour, ultimately leading to an enriched, safer life.
