The Commissioners wish to contract with up to 9 new providers, who are qualified to deliver the service specification and have tendered acceptable price rate cards, to maximise capacity in the Hampshire and Isle of Wight region.

This tender relates to the care and support element only and not the provision of housing or accommodation. Care packages are required for people with learning disabilities and autism currently living in the community or at the planning stages for those who will be living, in the near future, in their own self-contained accommodation as tenants.
