### II.2.4) Description of the procurement

Diagnostic and treatment are a function of the ICB however there are gaps in the community in fulfilling these functions in the event of a communicable disease outbreak response, in particular diagnostics (i.e. swabs/blood), contact tracing and post-exposure prophylaxis (PEP). This is a patient safety risk and creates inequalities due to potential delays in timely review and treatment and the potential to prolong outbreaks.

ICBs are required to have provisions in place to support effective, timely, outbreak response for the management of all communicable diseases in the community including education settings and asylum seeker accommodation. Under the Civil Contingencies Act 2004, ICBs are identified as a Category 1 responder and therefore have statutory responsibilities, duties and powers which are significant in handling a communicable disease outbreak.

This service is commissioned to cover all patients registered with a BCICB GP and all contacts identified through contact tracing from the outbreak/incident.

The service specification will cover individual or outbreaks of all communicable diseases, seasonal and non-seasonal, see below. This is not an exhaustive list:
