The Suttie Centre work in collaboration with NHS Grampian and are the only simulation centre within this area therefore the only supplier who can deliver this requirement for NES.

Delivering this training locally will also minimise the impact on clinical practise and reduce the travelling and associated costs of this for trainees and reduce carbon footprint.
