Award Stage will consist of Quality 60% and Price 40%.

Stage Two shall consist Tender response 20%, price 40% and social value 10%

Only the top three scoring providers will be taken through to Stage Three

Stage Three - Interview 20% and Presentation 10%

Service Provider's receiving a score of 4 or below will result in elimination from the process including the tender response / interview and presentation stages
