Bishop Challoner Catholic Federation of Schools has a separate Girls School, Boys School and 6th Form located on one site in Shadwell (London Borough of Tower Hamlets). Currently there are approximately 1,500 pupils across all 3 'schools'. The GCSE results are continuously improving and pupils achieve excellent A-level results. There are 210 teaching and administrative staff.

The new buildings project for Bishop Challoner was completed approximately 12 years ago.
