Only one economic operator has exclusive rights for this procurement, these biocompatible artificial kidneys prevent adverse reactions during haemodialysis. These are prescribed by a consultant nephrologist and are the only clinically compatible product suitable for the treatment of a small cohort of patients. No other reasonable alternative exists. The absence of competition is not a result of the artificial narrowing of the parameters of procurement.
