Torfaen County Borough Council and Blaenau Gwent County Borough Council are seeking a Development Partner to collaborate on various regeneration and community wellbeing projects. We are keen to select a partner that recognises and understands the challenges facing Welsh Valleys areas and who will play a crucial role in enhancing the local economy and improving infrastructure. As both Councils are Marmot Councils, regeneration will be aimed at supporting the achievement of our respective County Plans which are centred upon improving community wellbeing and reducing health inequity by taking action on the wider determinants of health.

The contract will also involve the development of an investment prospectus to attract further investment into the region.

#### Potential Roles and Responsibilities:

- Support the creation of an investment prospectus to showcase the various investment opportunities in the 2 county boroughs.
- Conduct feasibility studies and market assessments to ensure the viability of projects.

- Lead the design of development projects, ensuring plans meet economic, social, and environmental goals.
  - Manage the entire lifecycle of projects, including securing planning permissions and regulatory approvals.
  - Commission and coordinate with architects, engineers, and contractors to deliver projects within scope, time, and budget.
