Conflicts of interest identified among evaluators: 4. The non-conflicted members have assessed the nature and risk of this conflict, and have decided which steps to take to avoid or manage it. This resulted in excluding 2 conflicted members from decision-making and 2 potential conflicts were deemed not to require such mitigation and continued with the evaluation process.

5 key criteria selected (1) Quality and Innovation: 50% (2) Value: Pass/Fail (3) Integration, collaboration and service sustainability: 15% (4) Improving access, reducing health inequalities and facilitating choice: 25% (5) Social value: 10%.
