Support decision-making at incidents where mental health is a factor and during the decision-making process in the hub by ensuring all available information from partners and the Police is researched and understood.

Enhance the provision of mental health services in Humberside and improve service user experience.

Promote suicide prevention and actively support self-harm reduction.
