SECTION 2 - BACKGROUND

The Council invites competent and experienced Contractors to make submissions on a fixed price basis for the sampling, testing and monitoring as required in accordance with the environmental authorisations listed in Section 1 of the tender document. Tenderers are asked to provide a price for all services although the extent/frequency of services required may reduce or vary during the contract.

Contractors must provide a fixed price tender for the sampling and monitoring of

groundwater, surface water, leachate and landfill gas on a scheduled basis. The schedules are detailed in the specification. The monitoring and sampling schedule for the sites is detailed in the respective section in the form of tender. The Contractor shall include in the tender value all costs including man hours and overheads associated with the work. Travel costs may be reclaimed in relation to additional occasional consultancy works only. The Contractor shall ensure that all works in relation to the sampling and monitoring is in accordance with The Pollution Prevention and Control Regulations (Northern Ireland) 2003 and The Landfill Regulations (Northern Ireland) 2003.
