All criteria were determined to be equally important and therefore allocated same weighting of 20%.

The provider was assessed both for their current performance and potential future performance and provided evaluators with confidence in their ability to meet the

requirements of future contract.

In addition to the key criteria, the basic selection criteria used was Pass/ Fail and the provider 'passed' across all areas.
