The skips supplied to the Housing Services Department will be delivered to various locations across the Ashfield District as and when deemed necessary by the Authority for the use of Ashfield District Council Tenants to dispose of general household waste.

The skips supplied to the Repairs and Maintenance Section will be located at the Northern Depot, Station Road, Sutton in Ashfield, Notts. NG17 5HB. These will be utilised to dispose of the waste generated by our operations in relation to the Repair and Maintenance of Authority owned properties.

A Waste Transfer Station is accessible during the contract period for the transfer of fly tipped and operational hazardous and non-hazardous waste.

The maximum approximate radius of the district is approximately 10 miles from the Authority's Waste is generally consistent throughout the year, however the Authority could have periods whereby more waste is generated.
