The natural gas compressors on these compressor station are driven by gas turbines between 6MW and 12MW of rated power.

The primary objective of the Electrification Programme is to reduce the use of fuel gas in the operation of the Brighthouse Bay and Beattock compressors stations and associated fugitive emissions thereby aiding the reduction of greenhouse gas emission intensity by 50% (from 2010 level) by 2030 as outlined in Gas Networks Ireland's Low Carbon Pledge.
