#### VII.2.2) Reasons for modification

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

The care sector is currently facing an unprecedented crisis and existing contracted providers are struggling to deliver commissioned services due to the national staffing crisis throughout the care sector, hence the need to extend to provide stability rather than re-tender in the current climate.
