Stage 1: Gateway to Student Services and application process is as follows:

- 1. Student registers account
- 2. Student completes online bursary application.
- 3. Student application and supporting evidence is submitted and received by service.
- 4. Supporting evidence is validated by Service.
- 5. Manual assessment of the bursary application is undertaken by the Bursary Assessor.
- 6. Student account updated with application outcome and communicated to students.
- 7. Knowledge management provided to students via Student Awards Call Centre.
