### **Description**

UK Research and Innovation (UKRI) Science and Technology Facilities Council (STFC), wish to establish a contract for the provision of Compressed Air, Nitrogen Generators, Carbon Towers and Associated Services. The site address for delivery of the goods and/or services is:
