The equipment must be of a minimum specification so that it can operate autonomously, collect continuous time-stamped data, is small enough to be attached to eels and can work at the required depths / temperatures.

The contract is planned to start 01/01/2024 for a 3 year duration. The contract may be extended for an additional 2 years. The value covers the full 5 year contract length.
