The awarding of this contract is subject to the Health Care Services (Provider Selection Regime) Regulations 2023 - Most Suitable Provider Procedure. This is a Provider Selection Regime (PSR) confirmation of contract award notice. This contract has been awarded under the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award. This contract has now been formally awarded using the PSR Most Suitable Provider process. The contract was awarded to the successful bidder on 25th April 2025. The contract is for the period from 01/05/2025 to 31/08/2025 with an option to extend for a further 2 periods of 3 months. The estimated lifetime value of the contract including the extension option is £200,000.
