Cormac Solutions wishes to appoint an appropriately trained and qualified engineer working for a company which specialises in this type of work. This contract enables such a programme of inspections to take place and a full picture of the condition of all highway structures to be ascertained. The contract will initially be for 2 years with an optional extension for a further 2 year term. The intention is to appoint the most economically advantageous tenderer based on 60% Price, 30% Quality and 10% Social Value.
