Royal United Hospitals Bath (RUH) has an Occupational Health (OH) Team that supports the onboarding process for new staff and also needs to meet the Occupational Health needs of the existing workforce.

The OH team have found it difficult to recruit sufficient qualified staff to meet the demands on them. This is due to a lack of qualified people available in the market and the competitive geographical environment as they are bordered by several large NHS Trusts.
