• Increased engagement in inclusive provision that raises the aspirations and supports the development of young people between 8-19 years of age. This will enable all young people to access and engage in activities that develop their confidence and build their self-esteem.

- Reduce health inequalities, improve and maintain good physical and mental health. Ensuring that young people are informed and supported to make safe and healthy choices, and are referred to appropriate services when additional support is required.
- Ensuring young people feel safe in their communities and develop positive relationships.
- Partnership working with the City and other providers.
