There are eight optional one-year extensions. The Contracting Authority shall communicate its intention to extend the Contract Period with the Provider no later than 30 days prior to the end of the Contract Period.

Two months prior to the end of the Initial Term, the Provider shall provide to the Contracting Authority details of the Price for the extended period as reviewed pursuant to CPI ("Revised Price");

Should the Contracting Authority exercise their option to extend, the Revised Price shall be payable instead of the Price by the Contracting Authority following the end of the Initial Term until the end of the first extended period.

Should the Contracting Authority wish to further extend the Contract beyond the first extension, the above shall apply to each extension of the Contract and the reference to "Initial Term" shall instead be to Contract's existing extended period.
