A market engagement exercise NHSE499 in the form of a Request for Information (RFI) for school aged vaccination (including Flu) services across the North Region including the North East and North Cumbria (NENC), and Yorkshire & Humber (YH) resulted in feedback from the RFI applicable to the South Cumbria contract to be extended by a 5-month period to co-terminate with NENC & YH for inclusion in a North Region Tender process and to allow time to address other issues raised by suppliers.

**VII.2) Information about modifications**

**VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

This extension falls within the requirements of regulation 72(1)(c) of the PCR 2015

(i) The need for modification has been brought about by circumstances which a diligent contracting authority could not have foreseen.

Due to the RFI responses there is a requirement to take account of the request for an appropriate mobilisation period between 12 – 36 weeks as well as aligning the contract commencement and expiry dates to the academic year rather than the current financial

year and a review of the financial viability of the financial envelope.

(ii) The modification does not alter the overall nature of the contract.

This CM will not result in any change to the overall nature of the school aged vaccination (including Flu) services for South Cumbria and is fixed for a period of 5-months from 01 April 2023 to 31 August 2023.

(iii) Any increase in price does not exceed 50% of the value of the original contract or framework agreement.

The CM fixed 5-month period does not exceed 50% value of the original contract.

A procurement process is planned to lead to the publication of a contract notice in Find a Tender Service and Contracts Finder advertising an Invitation to Tender opportunity proposed for December 2022 for the delivery of a 5-year contract for School Aged Immunisations (including Flu) across Yorkshire & the Humber and North East and North Cumbria including South Cumbria for contract commence from 01 September 2023
