To modify the end date of the Accommodation with Care (Care Home) DPS from 30th September 2022 to 30th September 2024; this will result in additional spending on the DPS in line with current levels, the value of the spend during this time is anticipated to be approx. £90m.

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

This Accommodation with Care (Care Home) DPS is being modified to extend the end date to 30th September 2024, i.e. to add an additional 24 months, the value of the spend during this time is anticipated to be approx. £90m

The dynamic purchasing system will remain continuously open so that new providers may join.
