This modified process reflects the immediate nature and personal choice of Supported Living Services and maintains the principles of fairness, openness and transparency.

The application process has been issued by City of Bradford Metropolitan District Council in connection with a competitive procurement in accordance with the Public Contracts Regulations 2015 ("the Regulations).

Applicants are able to apply to join either in the initial application period or in subsequent rounds throughout the term of the PDPS.
