#### II.2.4) Description of the procurement

People leaving hospital in the Devon system under pathway 2 have a wide range of needs that require residential care. This includes the requirement for care provision to be able to support with complex manual handling (including hoist and stand aid transfer requiring the assistance of two people) and to support the needs of those who require the support of two staff overnight. It is also important that all daily living activities are taken with an enabling approach, to promote the person's independence and rehabilitation.

NHS Devon has awarded a contract for 6 pathway 2 block booked beds for a 6 month (+ 6 month optional extension) contract at a cost of £1,000 per bed per week. The contract may increase to 8 beds if capacity allows, this would increase the value below by £1,000 per bed per week utilised.

The initial value of the contract is: £156,000 for 6 months. (This value may increase up to a maximum £208,000 if both the additional 2 beds are utilised. The value may increase to a maximum of £416,000 if the optional extension is used.)
