This research project aims to make progress towards a better understanding of actual UK consumer exposure to food additives. The aim is investigation of an approach for estimating exposure to food additives through measurement of biomarkers in biological samples taken as part of the National Diet and Nutrition Survey (NDNS). The FSA is currently working with a research partner to measure concentrations of biomarkers of food additives (specifically non-sugar sweeteners) in NDNS urine samples, using analytical chemistry techniques.
