Mersey Care NHS Foundation Trust (MCFT) has awarded a contract to Liverpool Heart and Chest Hospital NHS Foundation Trust (LHCH), Thomas Drive, Liverpool, L14 3PE, for the provision of specialist cardiac consultant services for patients and service users of Mersey Care NHS Foundation Trust heart failure service in North Sefton. The contract value is approximately £10,000. (RBQ)

MCFT is currently in contract with LHCH for these services. The contract commenced 01 April 2025 for a period of 12 months.
