Provider responses were submitted and held on a secure electronic tendering system which evaluators accessed to complete initial evaluation against the scoring criteria, which was laid out in the procurement documents.

On completion of the initial evaluation, evaluation panel representatives met to agree a consensus score for each question. The consensus score formed the final score for each question.



All Evaluators completed training on the Evaluation process prior to their initial evaluation.
