Mersey Care NHS Foundation Trust (MCFT) has awarded a contract to Wirral University Teaching Hospitals NHS Foundation Trust (WUTH) for the provision of specialist clinical endocrinology services for patients and service users of Mersey Care NHS Foundation Trust Transcend service. The contract value is approximately £40,000.

MCFT is currently in contract with WUTH for these services. The contract commenced 01 April 2025 for a period of 12 months. The contract was awarded in accordance with the Provider Selection Regime Regulations under Direct Award Process A where there is an existing provider for the services and there is no realistic alternative to the current provider.
