The BFPS will ensure all breastfeeding women in Hull have access to breastfeeding peer support as well as specialist support provided by Baby Feeding Practitioners who will be based within local Maternity Unit's and the community providing support for the initiation and continuation of breastfeeding. This will be reactive to need and conducted face to face or via the telephone. The service will function across hospital, community and in the home of the mother where possible. The BFPS service will prioritise the more deprived wards where women are least likely to breastfeed in the city.
