DHSC (Department of Health) and OLS (Office for Life Sciences) is seeking to commission a supplier that will conduct a research project to understand the clinical impact of liquid biopsy tests on the early diagnosis of cancer in symptomatic patients presenting with abdominal symptoms in primary care. We anticipate that delivery will require a tripartite consortium comprising an independent evaluator and a liquid biopsy provider, with the capability to identify, establish, and manage engagement with point-of-care settings (NHS) for patient recruitment and participation.
