Assisted Conception is when a person or couple get pregnant (conceive) with the assistance of medical intervention (treatment). The Assisted Conception services include:

- In vitro fertilisation (IVF)
- IVF with intracytoplasmic sperm injection (ICSI)
- Intrauterine insemination (IUI)

The different treatments available can involve the use of donated eggs and sperm.

This is a zero-based contract based on activity and local prices. The contract expenditure for 2023/24 was £65,283.

This notice is for a Direct Award C PSR process to commence from the 11th of October 2024, the lifetime value of the contract to the value of circa £66,000. Under the test for considerable change this is within the permitted criteria (not exceeding £500,000 and 25%).
