They are licensed by the Human Tissue Authority (HTA) to procure, process, test, store and distribute Tissues and Cells for human application. The service will provide tissues and cells that are labelled with unique barcodes for traceability from the donor to the recipient and vice versa, and records will be kept for a minimum of 30 years after clinical use.
