Weather: The drone must be capable of flying in the rain (IP rated) and launch/land in a minimum of 12metres/second wind.6. Endurance: Minimum flight time of 2 hours.7. Flight Control: The drone must be operable via manual pilot input and some level of mission planning/autopilot.8. Portability: The drone needs to be easily transported in an estate car or small van and with a set-up time to be deployable in under 15 minutes.9. Manufacturer: Ability to support us with aircraft training and documented servicing/maintenance schedule.
