At least 40 suppliers are known to have been targeted so far.

Suppliers are advised that any email or communication purporting to be from NPL but having any domain name OTHER THAN 'npl.co.uk' is likely to be fraudulent.

Suppliers are advised to remain diligent and to question anything that looks suspicious by contacting NPL directly (contact details can be found at www.npl.co.uk) or by contacting the real Gary Phillips at gary.phillips@npl.co.uk who can confirm if any such communication came from himself.
