The requirement was identified on 7th October, with a supplier needing to be in place by w/c 17th October to allow sufficient checks to take place. it is not possible to carry out even an accelerated procurement (which can be run theoretically in 15 days) so as to allow any meaningful supplier checks to be carried out in advance of 1st November. The potential for fraud through this contract and the subsequent loss of public money (total fund flowing through this scheme are in the region of £50bn - £100bn) is not acceptable and requires that an urgent contract is put in place.
