2) Without access to such design drawings/information and technical specifications, data and knowledge, the United Kingdom Ministry of Defence is not in a position to be able to identify the exact technical requirements (including the original equipment manufacturer standards) which are required to ensure the proper operation, safety and suitability of the requirement; and

3) As a result, Thales UK Ltd are currently the only company with the technical expertise and know-how to undertake the services covered by the scope of this contract.
