VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

Increase the budget up to a maximum value of £15,078.68

from 01 April 2025 to 31 March 2026 to contribute towards the increased consultation fee for the delivery of Emergency Hormonal Contraception (ECH) by accredited providers from £11.84 to 15.30 per consultation.

VII.2.2) Reasons for modification

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

For the avoidance of doubt, the provision of the Public Contracts Regulations 2015 does not
