This is a zero-based contract based on activity and local prices. The contract expenditure for 2023/24 was c.£46,000.

This notice is for a Direct Award C PSR process to commence from the 29th of October 2024. The lifetime value of the contract to is circa £57,500. Under the test for considerable change this is within the permitted criteria (not exceeding £500,000 and 25%).
